CAR is delighted to welcome Dr. Marquita Grenot-Scheyer as the new Assistant Vice Chancellor of Teacher Education and Public School Programs. Dr. Grenot-Scheyer comes to the Chancellor's Office from CSU Long Beach (CSULB) where she served as Dean of the College of Education since 2008 and as the Director of the Math Science Teacher Initiative since 2006. ### **NEWS FROM THE CENTER**

We look forward to a fall meeting of our Council of Faculty Representatives on Friday, November 4, 2016 in Visalia. The meeting is being held at the site of the California Reading Association's Professional Development Institute. The California Reading Association (CRA) is graciously providing a room at the host hotel for our gathering. Council members are encouraged to participate in CRA's institute after our meeting. Literacy faculty across the state and beyond were saddened by the death of Dr. John Shefelbine in May 2016. John shared his passion for and knowledge about literacy education with teachers and teacher candidates for decades as a faculty member at CSU Sacramento, primary contributor to California Reading and Literature Project professional development programs, speaker in high demand, author, and colleague. He was be missed by many.

We are awaiting word on two grant applications and a What Works Clearinghouse (WWC) report related to the Expository Reading and Writing Course (ERWC). The National Professional Development grant, if funded, would allow project staff to revise ERWC modules to include integrated and designated English language development (ELD) and provide related professional learning for high school English language arts and ELD teachers in the Sacramento and Fresno areas. These teachers and preservice candidates from CSU Sacramento and CSU Fresno would then serve as co-teachers, working with English learner students. The Investing in Innovation Validation grant, if funded, would allow project staff to expand the course beyond California into Washington State and revise the curriculum to include grade 11 as well as grade 12. In addition, the WWC should be posting a review of the 2015 WestEd evaluation of the ERWC soon; currently the WWC lists a rating for the ERWC study of "meets WWC group design standards with reservations."

### **RICA UPDATE PLANNED**

CAR Co-directors Nancy Brynelson and Hallie Yopp Slowik met with California Commission on Teacher Credentialing (CTC) staff in the spring to discuss the need to revise the RICA in light of new standards and the framework. The CTC staff are very interested in updating the RICA specifications and exam and plan to take a recommendation to the Commission soon. Once the revision process is underway, the CTC will ask for stakeholder input. We will keep you informed of these developments and encourage all faculty to provide specific input regarding the content of the RICA once that process stars.

### ADOPTION OF REVISED CALIFORNIA TEACHING PERFORMANCE EXPECTATIONS

The CTC has released a Program Sponsor Alert (PSA 16-08) announcing the adoption of the revised California Teaching Performance Expectations (TPE) at the Commission's June 2016 meeting. The PSA contains important information on the process for Preliminary Multiple and Single Subject credential programs to transition to align with the 2016 TPEs and 2015 program standards. 
